Qualification of Parade Presenter (PP): PP must be relevant to the Renewables theme. Decade For A Renewable Planet Inc. reserves the right to refuse any PP. Also Decade For A Renewable Planet Inc. reserves the right to remove any PP before or during the event who violates the Terms and Conditions herein.

Parade Location/Plan: Our best effort will be made to locate every PP on a "first come, first serve" basis with the exception of PPs who pay a premium for preferred locations and large Sponsors. Decisions regarding precise Parade location are made at our sole discretion; however, the best positions are also allocated on a "first come, first served" basis. Decade For A Renewable Planet Inc. reserves the right to make modifications as needed. Exact location and number of your presentation will be treated on a "first come, first served" basis and communicated as soon as possible no later than 60 days prior to the event.

PP Personnel: At all times during parade hours PP will ensure a minimum of five employee/performers per 46 (forty six) ft are present within its presentation space. At least two employees/performers must be an adult over 18 years of age; children under the age of 12 are not permitted without written consent from Decade For A Renewable Planet Inc.. Employees/ performers must have proper attire including proper walking shoes and must not be scantily clad employees are not permitted nor any behavior, language, content or materials that are sexually explicit or offensive. Decade For A Renewable Planet Inc. reserves the right to remove such individual from the Parade.

Presentation Rules: PP will not project images or present/perform outside of its assigned area. PP must not cause interference with other PPs. Unfinished surfaces, packing boxes, refuse, and objects or noise, which deter the general appearance and character of the parade, are not permitted. No canvassing or direct marketing is allowed. No food or beverages can be distributed within your space.

Presentation Cancellation/Non-Attendance Policy: Cancellations are not permitted for parade space after December 31, 2008, such advice to be received in writing by registered mail to the Decade For A Renewable Planet Inc. address shown herein; 50% of pre-payments are non-refundable. Refunds are not permitted for non-attendance and for notice of cancellation received after December 31, 2008.

Transfer Policy: Your parade space cannot be re-assigned, transferred or sublet to anyone other than the company contracted herein. Nor can any other company's products and services be displayed without prior written approval from Decade For A Renewable Planet Inc..

Equipment and Services included: Departure housing, parade monitoring, water service are provided by Decade For A Renewable Planet Inc. at no extra cost. All other services must be contracted directly with skilled Contractors approved by Decade For A Renewable Planet Inc.. Warehouse/construction space to build your float is available months prior to the event; contact us for locations and costs.

Contractors: Decade For A Renewable Planet Inc. also offers Official Contractors for other services such as décor, furnishings, design, construction, sound, music, costumes, instruments, etc... You may use Contractors other than those indicated for these services. You agree to abide to venue rules and regulations as shown or directed at our site and herein.

Requisite Presentation Décor: All parade space must include professional signage, equipment that is in good working order, furnishings that are aesthetically pleasing and fixtures of commercial strength. No tape, pins, nails, clips can be adhered to float surfaces or those provided; if their use is necessitated, we request that these be out of sight.

Installation and dismantling: PP may complete set-up on at the Departure location(s) at 6:30 am, on the day prior to the parade date, May 28, 2009, and must be complete by 8:00 pm on the same day. Dismantling must not begin sooner than the return to the Departure location, on the day of the Parade, May 30, 2009, which must be vacated by 4:00 pm, May 31, 2009.

Laws/Rules: PP is solely responsible and agrees to comply with all applicable local laws, ordinances, including fire safety and health, and all union and labor organization rules and regulations of the operator and/or owners of the city of Toronto and property in which the DECADE Parade is held. With regard to fire safety, fabrics in your presentation must be flameproof and wiring must meet the fire department code and insurance underwriters' rules.

Insurance: PP acknowledges that Decade For A Renewable Planet Inc. and the venue/property do not offer insurance covering the PP's property and that it is the sole responsibility of the PP to obtain business interruption and property damage insurance covering such losses by the PP. PP also agrees to carry public liability insurance against injury to the person and property of other.

Limitation of Liability: Decade For A Renewable Planet Inc. is not responsible for any loss, theft or damage to the property of the PP, its employees or representatives. Further, Decade For A Renewable Planet Inc. will not be liable for damage or injury to persons or property from any cause whatsoever by reason of the use or occupancy of the parade space or the participation in the Parade by the PP. PP assumes entire responsibility for and hereby agrees to protect, indemnify, defend and save Decade For A Renewable Planet Inc., its employees, agents, harmless against all claims, losses and damages to persons and property, any charges and or fines and attorney's fees arising out of or caused by the PP or PP's installation, removal, maintenance, occupancy or use of the premises and rods, or part thereof, excluding any liability caused by the sole negligence of Decade For A Renewable Planet Inc. and its employees and agents.

Termination of event: In the event that the premises where the roads or buildings are to be held shall, in the sole opinion of Decade For A Renewable Planet Inc., become unfit or unavailable for occupancy, or shall be substantially interfered with, by reason of employee strike, injunction, act of war, catastrophic weather, declared emergency, health threat, catastrophe, fire or provincial or federal governmental agency or by reason of any other occurrence beyond the control of Decade For A Renewable Planet Inc., Decade For A Renewable Planet Inc. may cancel or terminate the Parade. In the event of such cancellation or termination, the PP waives any and all claims the PP may have against Decade For A Renewable Planet Inc. for damages and expenses and agrees to accept in complete settlement and discharge of all claims against Decade For A Renewable Planet Inc. the PP's pro-rated share of the total amount paid by all PPs less all costs and expenses incurred by Decade For A Renewable Planet Inc. in connection with DECADE Parade including a reserve for future claims and expenses in connection therewith. The event may alternatively be postponed to a future date and as such the terms herein also apply. Decade For A Renewable Planet Inc. assumes no liability for changes in schedule, date or location or parade presentation space availability.

Agreement: By signing the PP Agreement form and incorporating these terms by reference, the PP agrees to abide by these rules and regulations, and those of the venue and by the decision of Decade For A Renewable Planet Inc.. This agreement will become binding on both the PP and its acceptance by Decade For A Renewable Planet Inc.. All points not covered specifically are subject to the discretion of Decade For A Renewable Planet Inc.. Decade For A Renewable Planet Inc. may, in its sole discretion, make reasonable changes, amendments or additions to Presentation Terms & Conditions. Any such changes shall also be binding on PP equally with the other regulations contained herein.
